## History of found monument

(Whitmore Book 1 Page 239) 7" fir N.44 W. 34 feet changed to 10' by unknown person, reported in Book 6 at page 98 as a 14" fir N.40 W. 15.5 lks distance with healed blaze, and reported on T.C.S. Map B-1085 as a 15" D. fir N.39 W. 10'; (Found, now 16" fir with healed blaze N.39 W. 10' to approximated center of tree).

(Whitmore Book 1 Page 239) 8" fir N.55 E. 10.5 feet, and reported in Book 6 at page 99 as a 14" fir N.55 E. 17.5 lks distance with healed blaze, and reported on T.C.S. Map B-1085 as a 14" D. fir N.55 E. 11.4'; (Found, now 15" fir with healed blaze N.55 E. 11.4' to approximated center of tree).

(Whitmore Book 1 Page 239) 6" fir S.14 E. 24.5 feet reported in Book 6 at page 99 as a 14" fir S.15 W. 37 lks distance with healed blaze, and reported on T.C.S. Map B-1085 as a 15" D. fir S.14 E. 24.5'; (Found, now 16" fir stump 7' tall with healed blaze S.20 E. 24.5' to approximated center of stump).

(Whitmore Book 1 Page 239) 10" spruce S.34 W. 25.5 feet, reported in Book 6 at page 98 as a 14" spruce S.34 W. 39 lks distance with healed blaze, and reported on T.C.S. Map B-1085 as a 14" Dead spruce S.34 W. 25.5'; (Found, now 15" spruce stump 6' high with rotten face visible in partially healed blaze S.34 W. 26.5' to upper blaze).

(T.C.S. Map B-1085) 16" D. fir S.8 W. 5.9'; (Found, Now a 17" fir stump 7' tall with healed face. Distance measured to a nail in the E. side center of the tree).

Found 1" iron pipe 3' high 1.3' easterly of corner monument.

Found steel fence post with yellow U.S.F.S. tag 3' Southerly of corner.

Found orange carsonite post 2.3' Southerly of corner.
