Section corner common to Sections 3, 4, 9 and 10, T1S, R7W, W.M.,  
Tillamook County, Oregon.

ORIGINAL by Albert P. Wilson, October 30, 1891.  
Post; missing.

- 20" Hemlock bears N42½°E 55 lks.; missing
- 14" Hemlock bears S19½°E 80 lks.; now a 15" x 6 ft. high  
badly rotted stub with portions of scribes and axe work  
visible on burnt upper face, scribes BT exposed on  
lower face.
- 12" Hemlock bears S42½°W 75 lks.; missing.
- 12" Hemlock bears N11°W 14 lks.; missing.

NOTE: Distance measured to BT face.

RESTORATION by Louis W. Amort RE2311, November 12, 1953 (Book 2,  
page 317, Tillamook County Records).

1 ½"x36" galvanized iron pipe with 3" bronze cap, 30" in  
ground in mound of stone; in place.

- 77" Fir stump bears N26°E 8.0 ft.; now 4 ft. high and  
rotted with portion of scribe R visible.
- 72" Fir stump bears S50°E 72.3 ft.; now 6 ft. high and  
rotted with portions of scribes T1S R7W S10 BT visible.
- 38" Fir snag bears S16°W 93.4 ft.; now 50 ft. high with  
scribes T1S R7W S9 BT RE2311 visible. Distance measured  
93.8 ft.
- 86" Cedar snag bears N24°W 43.8 ft.; now a 2 ft. high stump  
with a 30 ft. high slab attached, no scribes visible.
- 4"x4"x60" white painted Cedar post 2.0 ft. South of pipe;  
laying on ground.

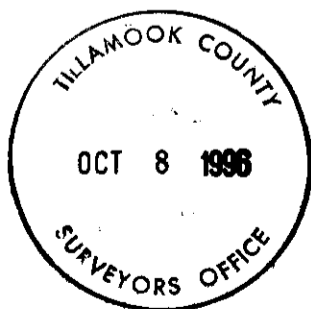
REWITNESSED September 11, 1996 Var. 19½°E

From above pipe with marks "LS1998 1996" added a:

- 13" Fir bears N88°E 35.95 ft. to face; scribed T1SR7WS3BT.
- 18" Fir bears S55°E 56.45 ft. to face; scribed T1SR7WS10BT.
- 29" Fir bears N38°W 55.3 ft. to face; scribed T1SR7WS4BT.

Metal location poster on new BTs and Amort's 38" Fir snag.  
3/4" brass washer marked "LS1998" nailed to face of new BTs.  
Reset Amort's white painted Cedar post 1.5 ft. SW of pipe.
