

Fir Stump, 7' tall, no marks visible, at record position (N 65° W 29.0'). (Book 2, Page 463) – Found stump remains of a Hemlock, 2.5' tall, scrib. partially visible, at record position (N 23° W 6.0'). (Book 6, Page 5) – Found rotten remains of a Hemlock, at record position (N 48° E 30.0'). (Rewitness #472) – Found hat section post, at record position (North 1.5').

New Bearing Trees: * 13" dia. Hemlock bears N 29° W 9.6', scribed, "T2S R10W 1/4 S36 BT", tagged and painted. * 11" dia. Fir bears N 87° E 4.1', scribed, "T2S R10W 1/4 S36 BT", tagged and painted. * Indicates yellow Tillamook County metal location tag attached. All new bearing trees have a nail and aluminum washer marked, "Till. Co. Surveyor", in face of blaze between the B and T.			
Location & Comments: This corner is located approximately 350' South of Yellow Fir mainline logging road, near the bottom of a draw.
