

Found Monument(s) and Accessories (Condition & Source): In 1958, in a dependent resurvey of a portion of T. 1 S, R. 9 W., Bureau of Land Management found no remaining evidence of the original corner or its accessories. A monument was set at proportionate distance along the section line. Found 3" dia. B.L.M. Brass Cap, up 0.5' in a 10" concrete cylinder with a rock collar. The monument is stamped as shown hereon. Found a hat section post South 1.9' from monument. (BLM) – Found 20" rotten Fir Stump, was (22" Fir), 18" tall, bears (N 67° W 8 1/2 lks. [5.61']), no visible markings. (BLM) – Found 12" rotten Fir Stump, 18" tall, bears (S 58° E 37 lks. [24.42']), no visible markings. (Rewitness Card #194) – Found 25" dia. Spruce, was (8"), bears (N 10° W 8.66') healed face and tag healed over. (Rewitness Card #194) – Found 30" dia. Spruce, was (10"), bears (N 85° W 18.41') healed face and tag healed over. () Indicates record information, Tillamook County Survey Records. [] Indicates record links converted to feet.

New Accessories set: Added yellow metal location tags to the found hat section post and the found bearing trees from Rewitness Card #194. Added 100 lbs. of concrete in a 12" dia. Cylinder around monument. Reset rock collar.		
New Bearing Trees Marked: *15" dia. Fir bears N 49° E 30.9', scribed "T1SR9W1/4S10BT", tagged and painted. *18" dia. Hemlock bears S 21° W 39.0', scribed "T1SR9WS15BT", tagged and painted. * Indicates an aluminum nail with washer marked, "Till. Co. Surveyor" in the face of the blaze between the scribed "B" and "T". Also, a yellow metal location tag affixed in an upper blaze.		
Location & Comments: Monument is located on the main ridge dividing the Kilchis and Wilson River drainages. Approx. 300' west of gravel spur logging road.
