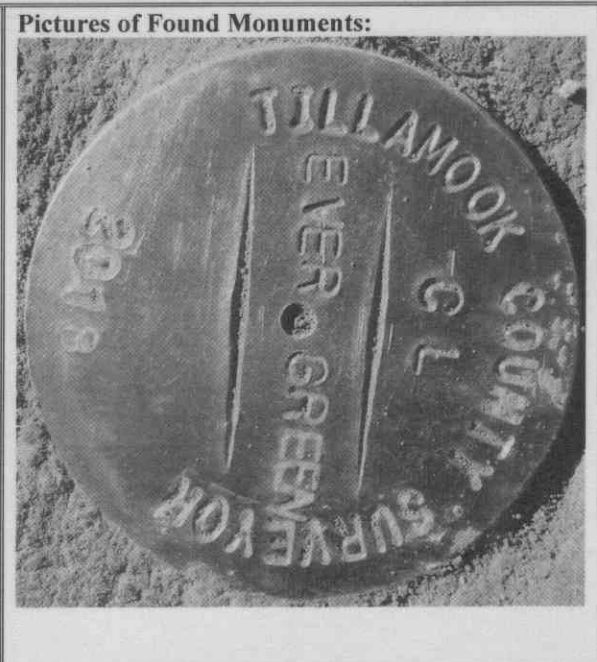

 Referenced the 1.5" Iron pipe with nails set in asphalt at 1.0' North and 1.0' West. Set a 2" diameter Tillamook County Surveyor Brass Cap in concrete flush with the road surface. The monument is stamped as shown hereon.

**Location & Comments:** Monument is located at the intersection of 3rd Street and Evergreen Avenue in Garibaldi, Oregon.

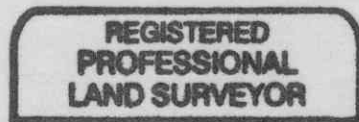
