History, condition, and sources: In 1857 under G.L.O. contract #67 a quarter section post was set and 2 bearing trees were established. In 1974 Karl F. Foeste (B-659) found no evidence of corner and re-established the corner by single proportion, set a 2" iron pipe with a 3" Crown Zellerbach Brass Cap, and established 2 bearing trees. In 1980 (Rewitness Card #443) Tillamook County Surveyor Office set 10" tile & cement around found 3" C.Z. Brass Cap with 2" iron pipe. In 2001 Tillamook County Surveyor Office added 2 bearing trees and a Hat Section Post. In 2023 (Field Bk. MR 14 pg. 33-34) Tillamook County Survey Office visited the 1/4 corner and found a 3" C.Z. Brass Cap (Stamped "LS 849 1/4 S5|S4 1974 CZ") in concrete as shown hereon in good condition.


