**Found Monument(s) and Accessories (Condition & Source):** The Monument of the Initial Point of Barview Heights was first set in 1912 by R. Jackson map C-4 Tillamook County Survey Records. In October of 1978, Willis F. Perley replaced the initial point with a brass cap and concrete collar set 2" below the surface; and reference points were set on map A-3635 Tillamook County Survey records.
