This Agreement Modification, hereafter "modification #9", is entered into by and between HELION, INC, hereafter "contractor" and Tillamook County, hereafter "county", pursuant to ORS 203.010. The parties entered into a Personal Services Agreement on July 11, 2012. The parties intend this modification to modify their earlier agreement only as to their expressions herein. The mutual promises of each are given in exchange and as consideration for, the promises of the other.

2. AGREEMENT PRICE AND AMOUNT

The price for the services and/or goods provided by contractor shall be an amount not to exceed ~~One Hundred One Thousand Nine Hundred Fifty Two and 00/100 Dollars (\$101,952.00)~~ *One Hundred Three Thousand Nine Hundred Ninety-One and 00/100 Dollars (\$103,991.00)*.

3. AGREEMENT TERM

The term or period of this Agreement shall begin July 1, ~~2020~~ *2021* and end June 30, ~~2024~~ *2022*.
