This matter came before the Tillamook County Board of Commissioners on July 6, 2022 at the request of Chris Laity, P.E. of Tillamook County Public Works – Solid Waste Department, for a notice of intent to award a contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:

1. Tillamook County advertised its call for bids in the Headlight Herald, a local newspaper of general circulation, on May 17, 2022; in the North Coast Citizen, a local newspaper of general circulation, on May 19, 2022; and in the Daily Journal of Commerce on May 11, 2022. Therefore, notice of solicitation for bids was properly published.
2. Tillamook County distributed twenty (20) copies of its bid solicitation documents in response to all potential bidder requests for copies.
3. During the call for bids period, Tillamook County received no objections, but issued two (2) addenda addressing concerns by potential proposers or other interested persons.
4. Tillamook County received four (4) timely responsible bids.
5. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the contract to the responsible bidder submitting the most advantageous, responsive bid.
6. The bid of C.R. WOODS GENERAL CONTRACTORS, INC. in the amount of Four Hundred Seventeen Thousand Two Hundred Eighty-Four and 87/100 Dollars (\$417,284.87) for Schedule A and Thirty-Three Thousand Three Hundred Thirty-Six and 00/100 Dollars (\$33,336.00) for Schedule B for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.

NOW THEREFORE, IT IS HEREBY ORDERED THAT:

7. Notice of intent to award a contract for the Construction of Manzanita Transfer Station – West Wall Improvements be and is hereby adopted. The board's

executive assistant is directed to promptly send by e-mail, a copy of this order to the successful bidder and all plan holders who provided an address.

- 8. This notice shall constitute a final decision of Tillamook County if no written protest of the notice of award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within seven (7) calendar days of the date of this notice of award pursuant to local contracting rules.
- 9. C.R. WOODS GENERAL CONTRACTORS, INC. shall submit the required insurance certificates and executed contract in order that a signed contract is presented to the Board of Commissioners at its regular meeting on July 20, 2022.
- 10. Upon this decision becoming a final decision, all proposals not otherwise selected are rejected.
