SUMMARY: This tax revenue will be used to pay for contractual fire protection services at the same level as currently exists. In 2021-2022 and 2022-2023, these fire services were paid by cash reserves, and prior to that, by a local option Levy which expired on June 30, 2021. The levy re-establishes the prior tax rate. It is estimated that the proposed rate will raise \$10,244.00 in 2023-2024, \$10,551.00 in 2024-2025, \$10,868.00 in 2025-2026, \$11,194.00 in 2026-2027 and \$11,530.00 in 2027-2028. The estimated tax cost for the measure is an ESTIMATE ONLY based on the best information available from the County Assessor at the time of the estimate. The current levy to provide for fire protection services expired on June 30, 2021. If this levy does not pass, the District will be without fire protection beginning July 1, 2023.
