Final Ballot Title The following is the final ballot title of the measure to be submitted to the district's voters. The ballot title notice has been published and the ballot title challenge process has been completed.

Bonds to Renovate, Improve Schools, Add Classrooms

Shall Willamina School District 30J issue up to \$2,500,000 in principal amount of bonds for schools; receive \$2,500,000 matching grant? If the bonds are approved, they will be payable from taxes on property or property ownership that are not subject to the limits of sections 11 and 11b, Article XI of the Oregon Constitution.

Summary 175 words which concisely and impartially summarizes the measure and its major effect.

District will receive 100% State matching grant of \$2,500,000 if bond measure is approved by voters. This measure would finance capital costs for the District, expected to include:

- providing five new classrooms to the main building;
- safety and security improvements, including to improve traffic congestion and pedestrian safety;
- expanding outdoor space to improve function and safety; and
- additional projects, including minor upgrades to facilities, furnishings, equipment, bond issuance costs.

The District will utilize a citizen oversight committee to ensure proceeds are used for purposes indicated and audits will be required.

Bonds may be issued in multiple series; each maturing within 10 years from issuance.

Due to existing bonds being paid off, the District estimates that this measure will result in a decrease to the District's bond tax rate to approximately \$0.49 per \$1,000 from \$0.53 per \$1,000 of assessed value. The actual levy rate for this measure may differ due to actual interest rates incurred and changes in assessed value.
