Five-Year Local Option Tax Levy for School Operations

Shall the District impose a \$0.75 per \$1,000 of assessed value for general school operations for five years beginning the 2025-26 fiscal year? This measure may cause property taxes to increase more than three percent.

With the lower-than-expected timber revenues and increasing costs to meet the needs of students, Neah-Kah-Nie School District #56 is facing significant cuts in operations. These proposed cuts would impact students and the community. If adopted, the District would be able to maintain current staffing levels, extracurricular, electives, and professional development.

If the levy fails, it will cause a significant budget shortfall for operations. Staffing levels and the ability to keep students engaged in activities outside the required offerings may be impacted.

Homeowners with an assessed property valuation of \$200,000 would pay \$150.00 in property taxes per year or \$12.50 per month at a rate of \$0.75 per \$1,000 of assessed value. The estimated cost for this measure is an ESTIMATE ONLY based on the best information available from the county assessor at the time of the estimate and may reflect the impact of early payment discounts, compression and the collection rate.

The measure would raise approximately \$2,084,052 in 2025-26, \$2,146,573 in 2026-27, \$2,210,971 in 2027-28, \$2,277,300 in 2028-29, and \$2,345,619 in 2029-30.
