) AWARD A CONTRACT

This matter came before the Tillamook County Board of Commissioners on May 8, 2024 at the request of Chris Laity, Director, Tillamook County Public Works Department, for a notice of intent to award a contract.

The Board being fully advised in the premises, records and files herein, makes the following findings:

1. Tillamook County advertised its call for bids in the Daily Journal of Commerce on April 22, 2024, and the Headlight Herald on April 23, 2024. Therefore, notice of solicitation for bids was properly published.
2. Tillamook County distributed eight (8) copies of its bid solicitation documents in response to all potential bidder requests for copies.
3. During the call for bids period, Tillamook County received questions related to the Bid Documents, and those were answered with the issuance of two (2) addenda to the bid on April 24, 2024.
4. Tillamook County received four (4) timely responsible bids.
5. Therefore, it is in the best general health, safety and welfare interests of Tillamook County to award the contract to the responsible bidder submitting the most advantageous, responsive bid.
6. The bid of ROAD & DRIVEWAY COMPANY in the amount identified in the amount of Seventy-Five Thousand and 00/100 Dollars (\$75,000.00) for the solicited project is accepted, subject to this decision becoming a final decision pursuant to local contracting rules.


NOW THEREFORE, IT IS HEREBY ORDERED THAT:

7. Notice of intent to award a contract for the Tillamook County 2024 Asphalt Procurement be and is hereby adopted. The board's executive assistant is directed to promptly send by e-mail, a copy of this order to the successful bidder and all plan holders who provided an address.
8. This notice shall constitute a final decision of Tillamook County if no written protest of the notice of award is filed with Tillamook County at its Board of Commissioners' office, 201 Laurel Avenue, Tillamook, Oregon 97141, within

seven (7) calendar days of the date of this notice of award pursuant to local contracting rules.




